REGINA AND MOOSE JAW ROAD SWITCHER AGREEMENT

- 1) Pursuant to Article 7, Clause (d) of the B of L. E. Collective Agreement, and Article 18, Clause (a) of the U. T. U. Collective Agreement, it is mutually agreed to extend road switcher limits for assignments headquartered at Moose Jaw beyond the thirty (30) mile limit to allow these assignments to reach Regina.
- 2) It is agreed that work performed by this Road Switcher service will not be done to the detriment of the yard assignments in Regina or Moose Jaw.
- 3) This arrangement may be revised or terminated upon thirty (30) days written notice by either party.
